Eligibility Criteria

- Senior or Mid-Level Management Customs Officers, age between 26-50 years and had never participated in any MTCP programme.
- Proficient in English and possess, preferably a tertiary education, with at least 5 years of working experience in customs matters relevant to the course.

Objective

- To recognize international trade, practices and International Commercial Terms (INCO-terms).
- To understand various types of customs commercial fraud particularly relating to the WTO valuation and WCO classification.
- To understand some of the modus operandi in customs commercial fraud.
- To apply some investigation techniques in combating customs commercial fraud.
