SUBJECT: - **E-LEARNING COURSE ON "SEMINAR ON THE DYNAMICS OF YOUTH AND TERRORISM" TO BE HELD FROM 25TH JULY TO 2ND AUGUST, 2022 UNDER THE MALAYSIAN TECHNICAL COOPERATION PROGRAMME (MTCP).**

The undersigned is directed to inform that the Government of Malaysia has invited **two (02)** nominations for the above training course. The Government of Malaysia will bear the full course fees for successful applicants. 2 The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:

- This programme is offered to **junior to mid-level officials** (two participants from each country) who are involved in either one of the following.
- **Law Enforcement:** law enforcement officials with knowledge and background in counter-terrorism.
- **Youth development Officers:** Public officials dealing with youth policies and development programmes.
- **Youth Leaders** :with knowledge and background in:
 - i. Youth programmes and
 - ii. Dealing with issues involving the youth.
- To be eligible to apply, applicants of the course are obliged to fulfill the following requirements.
 - i. Must be **between the ages of 26-46 years** at the announcement of the course.
 - ii. Must possess a university degree.
 - iii. Fluency in both spoken and written English.

Objectives:

- To provide participants with the knowledge and understanding of the psychological make-up and behavioral patterns of youths that are susceptible to terrorism.
- To create awareness among participating countries on the dynamics of youth and terrorism.
- To provide participants with an avenue to exchange views, experience and possible solutions on how best to address the issue and
- To provide the participants with the necessary knowledge to recommend to their respective governments on how to deal with the involvement of youth in terrorism.
