SUBJECT: TRAINING COURSE ON DIGITAL GOVERNMENT TRANSFORMATION TO BE CONDUCTED IN PERSON IN SINGAPORE FROM 21 TO 25 SEPTEMBER 2026 UNDER THE SINGAPORE THAILAND THIRD COUNTRY TRAINING PROGRAMME SG TH TCTP

The undersigned is directed to inform that the Governments of Singapore and Thailand have invited nominations for the above **Fully Funded** training course. The [brochure](#) of the subject training course is available at www.ead.gov.pk.

2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria

- Be Government employees (BS-17 and above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials from IT departments, digital transformation offices, and public service agencies responsible for modernizing government operations and citizen services.
- Proficient in English;
- In good health; and
- Prepared to participate actively in the programme.

Objective

- The course will provide participants with practical knowledge and strategic frameworks for implementing comprehensive digital government transformation. Participants will learn how to modernize government operations, design citizen-centric digital services, and build institutional capabilities for sustained digital innovation whilst ensuring cybersecurity, data protection, and digital inclusion across diverse populations.

3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by **July 09, 2026** positively. Interested officers are requested to apply online at <http://go.gov.sg/tctp-dgt2026> as required by Singapore (Mandatory). **Nomination without online application will not be considered by the host.**
