

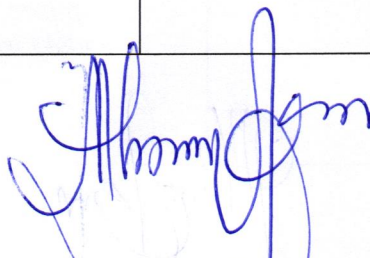

Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 18th June, 2026

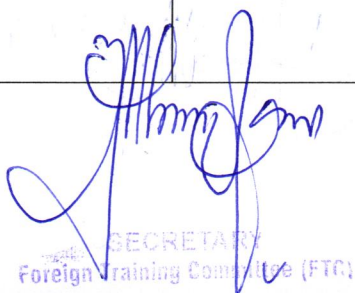
