Eligibility Criteria:-


The applicants should:-

- Be in a nursing position or supervisor in charge of planning, implementing, evaluating and managing infectious diseases control in Public Health services.
- Have at least 7 years working experience in the field of public health
- Be a graduate or equivalent
- Be licensed in clinical nursing and / or public health professional
- Proficient in spoken and written English
- Be between the age of thirty-five (35) and forty-nine (49) years
- Be in good health, both physically and mentally, to participate in the program.
- Women are encouraged to apply for the program
