Program aims to share ideas and approaches to gender and diversity in DRR and climate change.

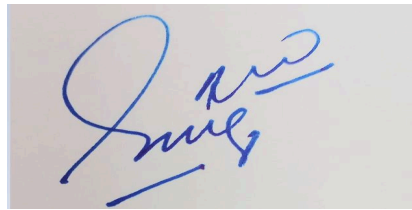
### **Eligibility Criteria:-**

The applicant should:

- Be a senior level officer of the organization in-charge of DRR or climate change adaptation and planning or in-charge of gender equality.
- Have more than 5 years' experience in the field of DRR and climate change.
- Be graduate of university.
- Be under the ages of 55 years.
- Women are encouraged to apply for the training course.


