Course Objective:

Participants acquire knowledge on life improvement approach and empowerment of rural women from good practices of Japan.

Eligibility Criteria: -

The applicant should:

- Be an officer engaged in extension activities or gender-related activities for rural women, such as life improvement (home economics), agriculture, community development.
- Have more than 3 years' working experience in the relevant field.
- Be a graduate of university or equivalent.
- Have command of spoken and written English.
- Be under age of 45 years.
- Must be in good health


