### **Program Objective**

Challenges and goals of Non-Formal Education in the respective countries are clarified, and Action Plans for Non-Formal Education promotion are prepared.

### **Eligibility Criteria:-**

The applicant should:

- Be an officer / manager in administration, planning and implementation of non-formal education or literacy education in federal and provincial government.
- Have command of spoken and written English
- Be a graduate of university or equivalent
- Must be in good health.
- Women are encouraged to apply for the program.
- Be under age of 50 years.


