The objective is to acquire core competencies to develop action plans for the promotion of sustainable tourism development through the appropriate conservation and utilization of cultural heritage.

Eligibility Criteria: -

The applicants should: -

- Be Administrative officer/ in charge of cultural heritage conservation or landscape conservation in federal or provincial government.
- Have more than 3 years working experience in relevant field.
- Be a graduate or equivalent in the related field of study.
- Women are encouraged to apply for the course.
- Proficient in spoken and written English.
- Be between the age of twenty-five (25) and fifty (50) years.
