2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:-

- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- The participants must be currently working in a relevant public institution such as the Ministry of Economic Affairs, Ministry of Finance and/ or related ministries and organizations responsible for public policy planning and evaluation.
- Should have proficiency in English.
- Have not participated in the same or similar KOICA fellowship program for the past three years.
- Having **minimum of 5 years** experience in the relevant field
- 45% of participants should be female.

Objectives:

- To enhance the capacity of officials from Ministry of Economic Affairs and Finance of Pakistan in strategic economic planning and policy performance management.
