SUBJECT: TRAINING COURSE ON SMART NATION CYBERSECURITY GOVERNANCE TO BE CONDUCTED IN PERSON IN SINGAPORE FROM 16 TO 20 NOVEMBER 2026 UNDER THE SINGAPORE COOPERATION PROGRAMME TRAINING AWARD SCPTA

The undersigned is directed to inform that the Government of Singapore has invited nominations for the above **Partially Funded** training course. 2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:-

- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials who are involved in cybersecurity policy planning and enforcement;
- Proficient in written and spoken English; and
- In good health.

Objective:-

- This course will draw on Singapore's Smart Nation experience and examine the concepts, strategy, policy, governance and technological aspects of cybersecurity through the sharing of perspective on current cybersecurity threats, challenges and best practices.

3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by **31st August, 2026** positively.
