SUBJECT: TRAINING COURSE ON BUSINESS FRIENDLY REGULATION FOR GROWTH TO BE CONDUCTED IN PERSON IN SINGAPORE FROM 16 TO 20 NOVEMBER 2026 UNDER THE SINGAPORE COOPERATION PROGRAMME TRAINING AWARD SCPTA

The undersigned is directed to inform that the Government of Singapore has invited nominations for the above **Partially Funded** training course. 2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:-

- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials who are involved in the regulatory sector;
- Proficient in written and spoken English; and
- In good health.

Objective:-

- This course will equip participants with the latest insights on the changing regulatory landscape and the mindset for designing and implementing a regulatory environment that supports businesses by reducing compliance burden and promoting innovation.

3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by **August 31, 2026** positively.
