## **OFFICE MEMORANDUM**

**SUBJECT: TRAINING COURSE ON HEALTHCARE MANAGEMENT TO BE CONDUCTED IN PERSON IN SINGAPORE FROM 06 TO 10 JULY 2026 UNDER THE SINGAPORE COOPERATION PROGRAMME TRAINING AWARD SCPTA**

The undersigned is directed to inform that the Government of Singapore has invited nominations for the above **Partially Funded** training course. 2. The eligibility criteria and objectives of the subject course are as under:

**Eligibility Criteria:-**

- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials who are involved in healthcare policymaking and planning;
- Proficient in written and spoken English; and
- In good health.

**Objective:-**

- This course will provide an overview of Singapore's strategies and initiatives to address healthcare needs, and how it is evolving to meet current and future challenges.
