SUBJECT: TRAINING COURSE ON FINTECH GOVERNANCE AND INNOVATION TO BE CONDUCTED IN PERSON IN SINGAPORE FROM 3 TO 7 AUGUST 2026 UNDER THE SINGAPORE COOPERATION PROGRAMME TRAINING AWARD SCTPA

The undersigned is directed to inform that the Government of Singapore has invited nominations for the above **Partially Funded** training course. 2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:-

- Be permanent government employee. (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials involved in the management and/or regulatory function of finance, digital innovation and cybersecurity;
- Proficient in written and spoken English; and
- In good health.

Objective:-

- This course will provide insights on the developments of Fintech and its adoption, and how to meet the regulatory challenges for sustaining a Fintech environment that balances Fintech benefits with risks management.
