 - Field operation officer
 - Farmers
 - Private sectors who are responsible for rural development and agricultural development.
- Participants are required to prepare a case study on a topic relevant to the workshop. focusing on their own country, and then present it with fellow workshop participants.

- Provide participants with knowledge and understanding of the RPF Model concepts under the principle of SEP including the expansion the Royal Project's success across other highland areas
- Highlight highland agriculture and development situation
- Further provide participants with knowledge and experiences of the good sustainable farming practices that will produce the food supply for future generations
- Provide a platform for participants to discuss and share good practices as well as building a concrete network.
