- Only short-listed candidates will be called for interview. Applicants shortlisted for interview shall present his/ her original documents along with set of attested copies of degrees/ certificates issued by HEC/ recognized board/ universities/ institute.
- Information provided in the application form will be verified and in case of any false or forged information and fake or bogus documents, Ministry of Economic Affairs reserves the right to cancel candidature at any stage (even after employment, if so discovered later) and to initiate a legal action against the applicant.
- The Ministry of Economic Affairs reserves the right to cancel the recruitment process in part or whole, increase/ decrease the number of posts as per requirement against any post at any stage without assigning any reason.
- No TA/DA will be admissible for the purpose of test/ interview.
