Separate sealed offer (excluding sales tax) for the vehicle supported by a Bank draft/pay order in favour of Economic Affairs Division as Earnest Money equivalent to 10% of the total value of the offer quoted for the vehicles may be attached. Cheques or bank guarantees will not be accepted as earnest money, Bids without earnest money will not be accepted.
4. Successful bidder has to pay GST @ 10% of the total value offered.
5. On acceptance of bid, the balance amount will have to be deposited within seven days, Delivery of vehicle will be given after full payment. In case of default, the amount of earnest money will be forfeited.
